ORDER GRANTING MOTION SEEKING RELIEF FROM ASSET FREEZE TO PERMIT THE MOVEMENT, STORAGE AND INSURING OF CERTAIN ITEMS OF ART

THIS CAUSE is before the Court on Defendant 1 Global Capital, LLC's and Relief Defendant 1 West Capital, LLC's Motion Seeking Relief from Asset Freeze to Permit the Movement, Storage, and Insuring of Certain Items of Art filed on January 30, 2019 (the "Motion"), ECF No. [145].

The Motion requests that the Court permit the removal, movement, and storage of certain art items located within 1 Global's premises belonging to the Ruderman Art Trust. 1 Global seeks to vacate the floor whether the art is located to reduce its monthly rent expenditure. No party opposes the Motion, although Defendant Carl Ruderman contends that the Ruderman Art Trust is not subject to the asset freeze and that the trustee is a necessary party to the Motion. *See id.* at 4. To the extent that the art items at issue are subject to the asset freeze, the Court finds

that the Motion presents an adequate basis for granting relief from the freeze — namely, to safeguard the assets of 1 Global for the individuals the SEC has identified as victims of the alleged conduct in the Amended Complaint. Accordingly, it is **ORDERED AND ADJUDGED** as follows:

1. The Motion, ECF No. [145], is GRANTED.

2. Defendant 1 Global Capital, LLC and Relief Defendant 1 West Capital, LLC may take any steps necessary to move, store and insure the art at issue in the Motion.

3. Upon determination of the ownership or appropriate disposition of the art, Defendant 1 Global Capital, LLC and Relief Defendant 1 West Capital, LLC may seek repayment of any funds expended in the movement, storage and insuring, to the extent necessary.
